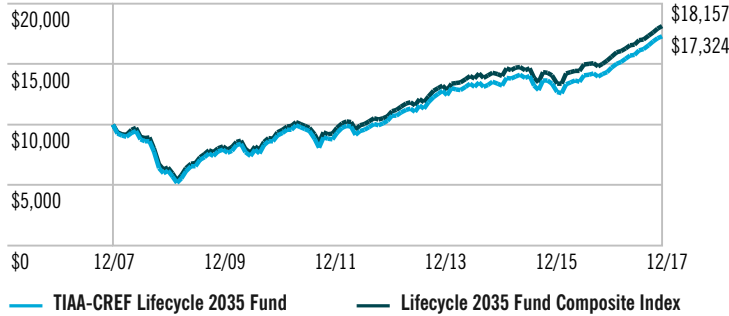


## TIAA-CREF Lifecycle 2035 Fund

### Hypothetical Growth of \$10,000 – Retirement Class

Previously, the Fund compared its performance to the Russell 3000 Index instead of the S&P Target Date 2035 Index. The returns of the S&P Target Date 2035 Index are more appropriate for comparison purposes because they reflect multi-asset class exposure for the same target date as the Fund. This waiver will remain in effect through September 30, 2020, unless changed with the approval of the Board of Trustees. The Management fee has been fully waived since the Fund's inception. The annual expense charge may include fees for the target-date fund and fees for the underlying funds; in general, target-date funds indirectly bear their pro rata share of the fees and expenses incurred by the underlying funds.

## Portfolio Strategies

The Lifecycle 2035 Fund seeks high total return over time through a combination of capital appreciation and income. Each of the TIAA-CREF Lifecycle Funds is designed to provide a single diversified portfolio managed with a target retirement date in mind. The target date is the approximate date when investors expect to begin withdrawing money from the Fund. Each portfolio invests in several underlying equity, fixed-income and direct real estate funds. Currently, the Lifecycle 2035 Fund's target allocation consists of an equity/fixed-income/direct real estate mix of approximately 75.6%/19.4%/5.0%. Over time, the Fund's target allocation will gradually become more conservative, reaching an equity/fixed-income/direct real estate mix of approximately 35.0%/60.0%/5.0% between 2042-2045. The Fund may deviate from these target allocations by up to 10% depending upon current market conditions and outlook.

## About the Benchmark

**Lifecycle 2035 Fund Composite Index** is a composite of unmanaged benchmark indices that represent the market sectors in which the Fund invests across the equity and fixed-income asset classes. The Composite Index changes over time to correspond to changes in the Fund's target allocations, and provides a more relevant benchmark for the Fund's performance as compared to the Fund's unmanaged broad-based market indices. **S&P Target Date 2035 Index** represents a broadly derived consensus of asset class exposure for the 2035 target retirement date based on market observations acquired through an annual survey of target date fund managers. The S&P Target Date 2035 Index returns include the fees and expenses of the exchange-traded funds that comprise that index. You cannot invest directly in any index. Unless stated otherwise, index returns do not reflect a deduction for fees or expenses.

## A Word on Risk

The Morningstar Rating™ for funds, or "star rating", is calculated for managed products (including mutual funds, variable annuity and variable life subaccounts, exchange-traded funds, closed-end funds, and separate accounts) with at least a three-year history. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a managed product's monthly excess performance, placing more emphasis on downward variations and rewarding consistent performance. The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars, and the bottom 10% receive 1 star. The Overall Morningstar Rating for a managed product is derived from a weighted average of the performance figures associated with its three-, five-, and 10-year (if applicable) Morningstar Rating metrics. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods. ©2018 Morningstar, Inc. ## Portfolio Statistics Definitions

**Beta** is a measure of the volatility of a portfolio relative to the overall market. A beta less than 1.0 indicates lower risk than the market; a beta greater than 1.0 indicates higher risk than the market. **Turnover Ratio** is calculated by dividing the lesser of purchases or sales by the average value of portfolio assets during a period. Turnover is based on the portfolio's fiscal year end and is not annualized if the reporting period covers less than 12 months. **Standard Deviation** is a statistical measure of the historical volatility of a mutual fund or portfolio; the higher the number the greater the risk.
